- The text of the report, up to 4 pages of A4 format (along with a list of sources used and taking into account figures, tables and formulas) is submitted as a file with the extension *.doc or *.docx.
- The file name must correspond to the surname and name of the conference participant in Latin letters (e.g.: Petrenko Ivan.doc).
- Text editor Microsoft Word. Times New Roman 14 point; line spacing 1.5; all margins 20 mm; paragraph indentation 10 mm; orientation portrait.
- In the text, references are given in square brackets [2, p. 56], where the first number indicates the ordinal number in the list of sources used, and the second the page number.

Sources should be cited only if referenced in the text. The bibliographic description of literary sources should be drawn up in accordance with the National Standard of Ukraine DSTU 8302:2015 "Information and Documentation. Bibliographic Reference. General Provisions and Rules of Compilation".
